The company is part of the Arnold Jäger Holding and will be integrated into the Parker Engineered Materials Group. The Jäger Group has been a pioneer in rubber to plastic direct bonding technology and a leading developer of 2K injection molding technology.

Jäger Automobil-Technik GmbH specializes in the development and production of molded rubber and plastics components (fully elastomeric variants and composite solutions) and is internationally renowned in the field of two-component injection technology. Automotive applications include door interiors, roof systems, bodywork and exteriors, and underhood components. The company employs about 250 people at two German (Osterode and Hildesheim) and one Polish (Gryfino) location.

The Jäger Group and Parker have been enjoying a long and successful business relationship.
